### From Holland Tunnel

Take the Holland Tunnel to the New Jersey Turnpike. Follow the New Jersey Turnpike to Exit 15E. Follow the signs for “Newark Downtown” (Raymond Blvd.). Stay on Raymond Blvd. for approximately 2½ miles (6 lights). Immediately after going under Penn Station, bear right to enter the parking garage. To valet park, after going under Penn Station, proceed through 1 traffic light and turn right into the Plaza, where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From Lincoln Tunnel

Take the New Jersey Turnpike South to Exit 15E. Follow the signs for “Newark Downtown” (Raymond Blvd.). Stay on Raymond Blvd. for approximately 2½ miles (6 lights). Immediately after going under Penn Station, bear right to enter the parking garage. To valet park, after going under Penn Station, proceed through 1 traffic light and turn right into the Plaza, where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From George Washington Bridge

Follow signs for Rt. 95 South to New Jersey Turnpike South. Take Exit 15E. Follow the signs for “Newark Downtown” (Raymond Blvd.). Stay on Raymond Blvd. for approximately 2½ miles (6 lights). Immediately after going under Penn Station, bear right to enter the parking garage. To valet park, after going under Penn Station, proceed through 1 traffic light and turn right into the Plaza, where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From South New Jersey

Take Garden State Parkway North to New Jersey Turnpike North to Exit 15E. Follow the signs for “Newark Downtown” (Raymond Blvd.). Stay on Raymond Blvd. for approximately 2½ miles (6 lights). Immediately after going under Penn Station, bear right to enter the parking garage. To valet park, after going under Penn Station, proceed through 1 traffic light and turn right into the Plaza, where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From the North

Take Rt. 21 South (McCarter Highway) approximately 2 miles. Make a left onto Market Street (just past the Hilton Hotel). Stay in the left lane and turn left onto West Raymond Plaza. Proceed to the next light. To park in the parking garage, proceed straight across Raymond Boulevard and turn left to enter. To valet park, turn left onto Raymond Blvd. Stay in the right lane past the building on the right. Enter Plaza where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From the West | Route 22

Take Rt. 22 East to Rt. 21 North (McCarter Highway). Take Rt. 21 North to viaduct onto McCarter Highway. Stay on McCarter Highway (Route 21) for approximately 1.5 miles. Make a right onto Market Street. Stay in the left lane and turn left onto West Raymond Plaza. Proceed to the next light. To park in the parking garage, proceed straight across Raymond Boulevard and turn left to enter. To valet park, turn left onto Raymond Blvd. Stay in the right lane past the building on the right. Enter Plaza where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### From the West | Route 280

Take 280 East and follow signs to Exit 15 (Rt. 21 South & NJPAC). Stay in left lane of Rt. 21 South for approximately a ½ mile. Make a left onto Market Street (just past the Hilton Hotel). Stay in the left lane and turn left onto West Raymond Plaza. Proceed to the next light. To park in the parking garage, proceed straight across Raymond Boulevard and turn left to enter. To valet park, turn left onto Raymond Blvd. Stay in the right lane past the building on the right. Enter Plaza where you see the “Legal Center Visitor Parking” sign. Pull up to the attendant.

### From the West | Route 78

Take Rt. 78 East Local Lanes to Exit 57 (to Newark Rte. 21 North). Take Rt. 21 North to viaduct onto McCarter Highway (Route 21). Stay on McCarter Highway (Route 21) for approximately 1.5 miles. Make a right onto Market Street. Stay in the left lane and turn left onto West Raymond Plaza. Proceed to the next light. To park in the parking garage, proceed straight across Raymond Boulevard and turn left to enter. To valet park, turn left onto Raymond Blvd. Stay in the right lane past the building on the right. Enter Plaza where you see the sign “Legal Center Visitor Valet Parking.” Pull up to the attendant.

### From Newark Liberty International Airport (EWR)

Exit Airport onto Rts. 1&9 North. Stay on left to Rt. 21 North (Newark). Take Rt. 21 over viaduct onto McCarter Highway for approximately 1.5 miles. Make a right onto Market Street. Stay in the left lane and turn left onto West Raymond Plaza. Proceed to the next light. To park in the parking garage, proceed straight across Raymond Boulevard and turn left to enter. To valet park, turn left onto Raymond Blvd. Stay in the right lane past the building on the right. Enter Plaza where you see the “Legal Center Visitor Valet Parking” sign. Pull up to the attendant.

### Public Transportation | NJ Transit

The Newark office of Sills Cummis & Gross is adjacent to Newark Penn Station which is serviced by NJ Transit.
